Selection and Evaluation Criteria

- The proposals will be selected by the Jury.
- Decision of the Jury will be binding on all applicants/applications. No communication from the applicants will be entertained.
- The selection committee may choose to speak to the applicant on phone while accessing his/her application.

Rules and Regulations

- Artists are responsible for preparing, framing, transporting and insuring the artworks.
- Artists will have to take care of the gallery and the exhibits as no attendant will be provided.
- Each application proposal and the submitted art work should be original creation of the artist.
- The proposals have to come from artists themselves. No gallery or managers can apply on behalf of the artists.
- IAFA will help in liaisoning with the media and will assist in providing the list of invitees forthe distribution of the cards and publicity on social media.
- The publicity material will have to be prepared in consultation with the Academy.
- Qualities such as creative excellence, originality, creative use of materials and presentation are among some of the criteria to be considered for selection.
- Artists should cross check whether the data recorded in the CD/DVD/Pen drive has actually been recorded. If a CD/DVD/Pen drive containing data is corrupted or does not open due to a fault in the storage device the application will be rejected.
- Any kind of canvassing will lead to immediate rejections of the application.
- Application may be sent by post or hand delivered at the office of Indian Academy of Fine Arts, M M Malviya Road, Amritsar.
- Incomplete forms and applications will not be considered.
- Self-attested copies of supporting documents on age, academic qualifications and achievements must also be enclosed.
- Proposals by email or electronic media will not be accepted.
- If an applicant does not have sufficient number of art works for holding a solo exhibition slot but the Jury thinks some of her/his works are worth exhibiting in a group show then the Jury can consider a group exhibition of many such artists. In this case applicant has to give his/her consent to be considered for a group show as well.
- Academy does not take responsibility for any injury or harm caused due to any accident or any other reason, during travel/transport of personnel or exhibits, installation/exhibition/uninstalling period of the exhibits at the Academy premises, to artist/helpers/installation team, etc. If the artist requires, he/she may get an insurance cover from his/her own resources for artworks, him/herself and team members involved.
- The views expressed in the exhibition will be the sole responsibility of the artist. IAFA holds no responsibility for the views, thoughts, images or any other content to be shown by the Artist.
